The Big News - SB 966 Vetoed!

Thank you for helping defeat Senate Bill 966!

The Pharma-backed legislative proposal that would have made it much harder for employers to secure the most cost-effective and safe medications for their employees was vetoed by Gov. Gavin Newsom on September 28, just two days before his deadline to act on all legislation.

In a <u>press release</u> following the veto, CAPA shared:

"We applaud Governor Newsom for his dedication to putting California's small businesses, their employees and their families ahead of Big Pharma profits. SB 966 would have resulted in higher health care costs for millions of Californians at a time when they're already grappling with an affordability crisis. We look forward to continuing to advocate for policies that confront the ever-increasing cost of prescription drugs moving forward."

We anticipate that next year will present more threats to your health care affordability and want to assure you that we will continue to advocate for employers and the 29 million Californians with employer-based health care coverage.
